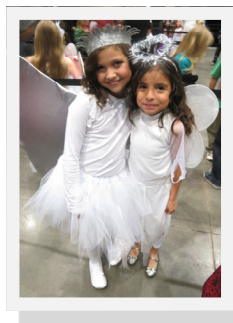
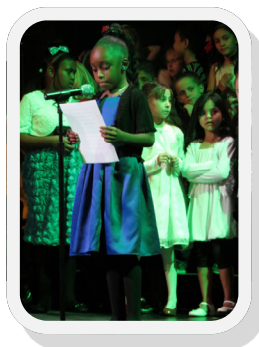

How does it work?

Simple. The Arizona Tax Credit program allows ALL taxpayers with an Arizona income tax liability to make a payment of up to \$400* to their favorite public school and receive a tax credit against their state obligation. Because it's a tax credit, you do not pay anything extra.

**Maximum credit is \$400 for married couples filing jointly and \$200 for individuals.*



Do I have to live within Imagine Rosefield's boundaries?

No, any individual who pays Arizona State income tax can give to Imagine Rosefield.

Can I designate what the money is spent on?

Yes. You have the option of designating the specific class or extracurricular activity your donation will support.

Why should I give money to Imagine Rosefield?

With limited school funding, students do not always have the opportunity to participate in a wide variety of extra-curricular activities. School tax credit donations can provide Imagine Rosefield students with opportunities such as field trips, after-school programs, tutoring, arts, music education and after-school sports. In addition, the funds can help to pay for uniforms and equipment for various extra-curricular activities. Simply put, tax donations make possible a wide variety of learning opportunities that our students might not otherwise experience.



Do I have to donate the full \$200 or \$400 all at once?

No, you can choose to donate up to the \$200 or \$400 limit in installments at any time during the calendar year, or you can donate it at one time. If you do not wish to donate the full amount, any amount you choose would be valuable to our students and appreciated by our schools. Just make sure all donations are received by the school no later than December 31st.
